## INTRODUCTION

This Privacy Statement applies between Acubed.IT and the user of this website. Acubed.IT is committed to safeguarding your privacy. This statement outlines how we collect, use, and protect any data provided by you or collected by us in relation to your use of the website.

## Please read this Privacy Statement carefully.

## **DEFINITIONS AND INTERPRETATION**

In this Privacy Statement, the following definitions are used:

- 1. **Data:** collectively all information that you submit to Acubed.IT via the website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws.
- 2. **Data Protection Laws:** any applicable law relating to the processing of personal data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation.
- 3. We or Us: Acubed.IT
- 4. **User or you:** Any third party that accesses the website and is not either (i) employed by Acubed.IT and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Acubed.IT and accessing the website in connection with the provision of such services; and
- 5. **Website:** the website that you're currently using, <u>https://www.acubed.it</u>, and any sub-domains of this site unless expressly excluded by their own terms and conditions.

In this Privacy Statement, unless the context requires a different interpretation:

- a) the singular includes the plural and vice versa.
- b) references to sub-clauses, clauses, schedules or appendices are to subclauses, clauses, schedules or appendices of this Privacy Statement.
- c) a reference to a person includes firms, companies, government entities, trusts and partnerships.
- d) 'including' is understood to mean 'including without limitation'.
- e) reference to any statutory provision includes any modification or amendment to it.
- f) the headings and sub-headings do not form part of this Privacy Statement.

## SCOPE OF THIS PRIVACY STATEMENT

This Privacy Statement applies only to the actions of Acubed.IT and users with respect to this website. It does not extend to any websites that can be accessed from this website including, but not limited to, any links we may provide to social media website.

For purposes of the applicable Data Protection Laws, Acubed.IT is the 'data controller'. This means that Acubed.IT determines the purposes for which, and the way, your data is processed.

#### HOW WE COLLECT DATA

We collect data in the following ways:

- a) data is given to us by you; and
- b) data is collected automatically.

#### DATA THAT IS GIVEN TO US BY YOU

Acubed.IT will collect your data in number of ways, for example:

a) when you contact us through the website, by telephone, post, e-mail or through any other means, in each case, in accordance with this Privacy Statement.

#### DATA THAT IS COLLECTED AUTOMATICALLY

To the extent that you access the website, we will collect your data automatically, for example:

 a) we automatically collect some information about your visit to the website. This information helps us to make improvements to website content and navigation, and includes your IP address, the date, times and frequency with which you access the website and the way you use and interact with its content.

#### **KEEPING DATA SECURE**

We will use technical and organisational measures to safeguard your data, for example:

- a) access to your account is controlled by a password and a username that is unique to you.
- b) We store your data on secure servers.

Technical and organisational measures include measures to deal with any suspected data breach. If you suspect any misuse or loss or unauthorised access to your data, please let us know immediately by contacting us via <u>enquiries@acubed.it</u>.

## DATA RETENTION

Unless a longer retention period is required or permitted by law, we will only hold your data on our systems for the period necessary to fulfil the purposes outlined in this Privacy Statement or until you request that the data be deleted.

Even if we delete your data, it may persist on backup or archival media for legal, tax or regulatory purposes.

# **YOUR RIGHTS**

You have the following rights in relation to your data:

- a) **Rights to Access -** the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is 'manifestly unfounded or excessive'. Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
- b) **Right to Correct -** the right to have your data rectified if it is inaccurate or incomplete.
- c) **Right to Erase -** the right to request that we delete or remove your data from our systems.
- d) **Right to Restrict our use of your data -** the right to 'block' us from using your data or limit the way in which we can use it.
- e) **Right to Data Portability -** the right to request that we move, copy or transfer your data.
- f) **Right to Object -** the right to object to our use of your data including where we use it for our legitimate interests.

If any court or competent authority finds that any provision of this Privacy Statement (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this Privacy Statement will not be affected.

Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.

This agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
